MIS 1 - Attendance

Overall Attendance:

- GOAL is 90%
- 23-24 - 86.61%
- 24-25 - 87.39%

Chronic:

- GOAL is 43%
- 23-24 - 48.2
- 24-25 - 51.3%

Chronic Attendance @ Similar Schools:

- West 44.13%
- Lake 47.97% (+10.45 previous)
 - Montebello 48.21%
 - Hamilton 50.18%
 - Manual 56.23%

Attendance is a challenge right now and not just in DPS.

What is the attendance Team Doing with this data?

- Calling Families CUSP families (88-92%)
- Reaching out to students with very low attendance to see what we can do to help
 - Often it's transportation
 - Complications at home
- Calling kids in for 1:1s with Sutherland
- One next step...
 - Target our cusp families by sending postcards to them (staff meeting on Friday)

ELD for 25-26

- BVIS Multilanguage Education (MLE) programming requires a teacher or para with ELA S certification in on staff at BVIS (based on our # of multi language learners).
 - ELA S =
 - English as second language Spanish-Instruction
 - This cert. Means the teacher has passed the Spanish Language Proficiency Exam
- We did not have someone with ELA-S Certification in the ELD classroom this year, and we need this for next year (as per DPS requirements).
- We are given ~\$38,000 funding for ELA-S teacher or para
- Due to budget restraints, we cannot hire an additional ELA S certified staff member (in addition to current staff)

- Make a program change and post for an ELD, ELA-S certified instructor in order to meet DPS requirements for MLE department.
- Reduce current ELD teacher.
- Grade levels are pure
- Class sizes relatively low
